

## **Amount of the dividend and option to receive payment of dividend in the form of shares**

**Vélizy-Villacoublay (France), March 23, 2017** – Dassault Systèmes (Euronext Paris: #13065, DSY.PA) announces that the Board of Directors held on March 16, 2017 decided to propose to the next General Meeting of Shareholders of May 23, 2017 the approval of a dividend of fifty-three eurocents (€0.53) per share for the year 2016.

As in 2016, it will also be proposed that each shareholder be granted the option to choose to receive payment of the dividends in the form of shares.

Shares will be traded ex-dividend as of May 30, 2017 and dividends made payable as from June 26, 2017.
